TERN RAFTS Dick Beeden



We have been investigating the possible purchase of a new tern raft. Lincolnshire Wildlife Trust is using an interesting design which they have shared with us, see picture above. They have told us that the rafts have proved very attractive to Black-headed Gulls, Coots, Moorhens, Oystercatcher, Canada and Greylag Goose as well as terns. The design is easily movable and can be placed on the water as the first terns arrive back on migration. After the breeding season some rafts were pulled close into the shoreline and the nesting substrate removed, others were taken out of the water completely. The rafts (fibreglass) were designed to be split in half to keep the weight down, so that two people could lift the platform out of the water and they are easily towed out by a small boat.

So as not to spoil the view over the lake the platforms were designed to sit quite low in the water - the height being adjusted by the amount of gravel put on them. They are basically an upturned saucer shape, with flotation pods underneath filled with polystyrene block with drainage holes to keep the substrate dry. The rafts were anchored by four simple mud weights from each corner, with hanging 'angels' on the ropes to keep them below the surface.

Joined together they make a nest platform of 4 square metres, with a sloping skirt which deflects wave action and stops 'wave slap' with its consequent spray onto the nesting area and also stops the rafts rock violently in windy weather. The sloping sides also helps if a chick falls off the raft, it could climb back up.

EVENTS ON THE RESERVE

BIRD REPORT Steve Carter Wildlife Recorder

March arrived with restricted birding owing to Covid with no list in the hides at month's end. The first swallow was seen in April and a cuckoo was heard calling at Cook's Wood opposite Stocker's farm. Here wader passage on the flooded field provided Ruff, Dunlin and 2 Little Ringed Plovers. Rain arrived at the end of April followed by hailstones and heavy showers in May, however a Whimbrel and 4 Wood Sandpipers were spotted which was fantastic. Summer progressed in July with heavy vandalism and poor public behaviour which blighted the reserve. Oystercatchers and Common Sandpipers were seen in July with a single Barnacle goose. A few Hobby were present in August and at month's end 2 Raven were seen over the west side of stocker's. Finally Common Buzzard feeding a juvenile above Stocker's farm was a breeding record.

TREASURER'S REPORT year ending 31.12.19

These are the audited accounts I would have presented at the AGM had it not been cancelled due to Covid.

Figures for the year ending 31 December 2019 are below alongside 2018 figures. Figures in brackets below also refer to 2018 for comparison.

Gross income for 2019 overall was much higher than in 2018 because of the grant from Groundwork Trust of almost £13,000 being their share of the fencing for the cattle. Otherwise income was up by about £300 reflecting about an additional 30 members. Gift Aid refund at about £1,200 remained about the same as in 2018. Paid up membership increased to 657 from 633.

Expenditure more than doubled to about $\pounds 29,723$ ($\pounds 14,714$) mainly due to spending of some $\pounds 26,000$ on fencing the three meadows in order to graze cattle. Administration and other costs stayed broadly the same as in 2018. Our third party liability insurance with Zurich for working parties and walks in particular remained competitive at £289.

In summary FoSL's accumulated funds as at 31 Dec 2019 stood at £15,128 (£24,745), down about £9,600 on 2018 as the cattle project got underway.

Thanks are due to Rachel Rooker FCCA of Acumist Lower Rd, Chorleywood for kindly scrutinising FoSL's financial records for 2019 pro bono.

Some figures for this year so far.

Income is currently approx £8,000 with 635 paid up members with balances standing at about £22,500. This compares favourably with last year. So far this year we have spent only about £1,800 due in the main to restrictions placed on our activities by Covid

Anyone who last paid in 2017 had until 30 Sept to respond after which they were removed from the mailing list.

There are no proposals to change the subscription for this year or 2021
